SERVICE FILE AVAILABLE

Through the efforts of Donald Berger of Portland, Oregon and Congressman Wendell Wyatt, you will find an accompanying alphabetical index of microfilm copies of recovered records in the Philippine Islands, records available to all veterans. This list is invaluable to those who are preparing claims with the VA, those who wish

to prove the validity of their present claims, or those thinking of initiating a claim.

The alphabetical listings is an index to the P.O.W. records located at the United States Army Administration Center (USAAC), 9700 Page Boulevard, St. Louis, Missouri, 63132. Any former prisoner of war from the Philippines area, including those civilians interned in the Philippines and Japan, can obtain extracts by contacting his service officer with a request that the VA obtain from USAAC those records useful in substantiating his claims with the VA, or other agencies needing such documentation to aid in a claim for compensation. I am sure no difficulty will be experienced as already the USAAC has supplied extracts to individuals and for the VA Regional Office in Portland.

Look through the index carefully and decide if any of the titles are appropriate to your claim. If so, have your service officer send for the extracted records applicable to your specific case or claim. This and related topics will be discussed at length at the Atlanta convention; at that time, any questions you might have will be answered. The information received at the convention on this subject alone makes your presence well worth the time and effort.

Be sure to save this copy, it should be retained with your VA information.

The format for this Quan was changed to rush this information to you, bring it along to the convention for references.
